

Rich's Ramblings Rich Carroll

The electric vehicle world is just about to enter a new phase, one where EV's pay their share of road use taxes. In the past road use taxes were added to our fuel prices, both for gasoline and diesel fuel. Just how much we pay is somewhat hidden, because we pay for gasoline by the gallon, and the price we pay includes sales tax (based on % over cost) and federal gasoline taxes (based on 18.4 ¢ per gallon.) To add additional confusion, state and local sales taxes vary significantly by community. There is considerable variation from one incorporated area to another, one county to another, and whether the area is a home rule district. Sales tax usually runs from 7% to 10.75%. Since some of the taxes are percent based and some gallon based, it becomes a little more difficult to get an exact number. As of April 2015, the average fuel tax for gasoline in Illinois is 52.5¢ per gallon. Supposedly, this goes to maintaining roads and highway infrastructure. In Illinois, electric vehicles do not pay a share to the road use taxes. Hybrids and ultra high mileage vehicles pay less than comparably sized gasoline vehicles. Just to propose some numbers for comparison, we'll compare a 30 MPG car what is driven 15,000 miles a year. 15,000 miles per year ÷ 30 MPG means the vehicle consumed 500 gallons of gasoline per year, and if the tax is 52.5¢ per gallon. then that vehicle paid (500 gallons x \$0.525

dollars per gallon) or \$262.50 yearly in road use taxes, (hidden in the cost of the gasoline).

Oregon has started an alternative program, effective July 1, where residents can enroll in a program to pay  $1.5\phi$  per mile. If they use fuel, they will receive rebates for the cost of the fuel. Calculations: 15,000 miles/year x 0.015/ mile is 225 per year.

For gasoline vehicles, the Oregon program allows residents who pay per mile rather than pay per gallon to save a small amount over the existing system. Using this system, EV's and hybrids do pay for highway and infrastructure replacement, not by a motor fuel tax but by a 'use tax', or as Oregon named it a Road Usage Charge.

Does this make sense for states to start to charge this way? Absolutely. I recently saw a Tesla in traffic with an EV plate with an Illinois EV plate number just over 4000. I am quite certain we'll have EV license 4500 in the near future, and if you assume average use of 15,000 miles per year, that is over a million dollars each year in new state funds. I know these OBDII printed circuit boards with communication can be purchased for around \$5 to \$8 each, so with distribution costs, the program might cost the state \$50,000 or \$70,000 to start.

But, there are some serious concerns by some drivers over the implementation. The OreGo (their name for the program) is implemented by a recording device that plugs into the OBDII port under the dash, and that device uses GPS to follow the vehicle and add up the miles traversed. The OreGo program has promised to use vendors that only report to the state the mileage, and do not report where your car was driven. Law enforcement won't have access to individual data without a judge's order. Recently a vendor was added to the program whose device does not include a GPS, simply a mileage recorder. Many citizens have serious privacy concerns with the new legislation, and refuse to participate, so the program has been limited to a voluntary test so far.

Please remember that this OBDII port that is used is the most common way that hackers can obtain access to your car for commands and information. Attaching a radio (bluetooth, wifi, and others) to the OBDII port creates a very serious security risk. Certainly, attaching a printed circuit board without knowing the contents in detail is quite foolish.
