Rich's Ramblings Rich Carroll

All the news that's fit to print, . . . and then some. I receive a good amount of 'industry news' each month, which is a great source for column starters. This month seemed fairly wacky, though. Let's classify some of the more unusual:

Big Surprise Department

CEO and founder of EverCharge, a power management system provider, said, "Every day we hear from more and more car owners who need an easy way to get power to parking spots in an economical way." (uh, duh??)

ChargePoint CEO Pasquale Romano, said, " . . . it's possible for even more businesses to offer EV charging to their employees and customers." (Wow, what a revelation!)

The big players are also susceptible to making grandiose statements that would have gone without saying. Elon Musk said, "Eelctric Cars . . .are really the key to a sustainable future." Elon also said, "we're super supportive of anyone who wants to to cooperate in sharing the Supercharger network."

"Smart grids and electric vehicles are rapidly evolving," per Maroš Šefčovič, VP of the European Commission and a Slovak diplomat. He also continued by stating that harmonized standards between countries would minimize trade barriers. (And someone paid good money for this recommendation)

Unusual references in statements

Nissan and Ecotricity, a charging network, have demanded that the UK government issue official road signage regulations for EV charging points. Their press release notes that there are 9,000 charging points in the UK with no commonality to signage. They noted that there are official signs for "Migratory Toad Crossings" of which 140 signs are maintained. (Likely true, but somewhere I missed the connection)

New markets in "developing areas"

Anders Gadsbøll, Managing Director of Renault Norway, announced seven new 22kW chargers on the tourist route between Finland and Norway, and into Lapland. Anders said, "We expect that many of our customers want to drive EVs from Norway to Finland." Lapland isn't that big, but Renault Norway obviously has big plans. I do hope their plans exceed the wild production numbers announced in Russia.

"Say it ain't so, Joe . . "

Get ready for two announcements by Dmitry Medvedev, who is the Prime Minister of Russia. Prime Minister is a daunting position in today's world, and Medvedev first decreed that all gas stations in Russia must be equipped with public EV chargers by November 2016. (I personally don't believe that is anywhere near a rational goal, but perhaps he will ally with 360Green, who also is no newcomer to grandiose plans.)

Medvedev also discussed EV sales with the Moscow Times, and he reported many EVs being imported, noting Tesla, BMW, Mitsubishi, and Nissan. But the most interesting number he disclosed was about the EL Lada, built by Russian automaker AutoVAZ. Lada has been around as an auto manufacturer for about 50 years, and have exported a large number of Ladas to developing countries. Their early early cars were mostly made with older Fiat designs and dies, and unfortunately, the dies were mostly worn out by the time they reached Russia. But they did produce hundreds of thousands of cars, and quality has gone up in the recent years. (Actually quality had nowhere else to go, but up)

They have apparently been producing the EL Lada since 2011, and total production (for 4-½ years so far) has been less than 50 cars.



Medvedev announced that sales for the last six months have declined by about 25%. Doing some quick math, they likely produced about 15-20 cars a year, and for the six month sales to have dropped by 25%, can only mean one thing. If you sell 8 cars in six months, and the sales go down by two cars to selling only 6 cars in six months, that is a 25% reduction. So losing two sales in a six month period has caused a 25% decline in sales. (That 25% number doesn't lie, but it sure doesn't tell any useful truths.)

The sales numbers for Russian made EV's (they only make the EL Lada) are so dismal, that I wondered if the hobbyists of the FVEAA had made more EV's than were produced in all of Russia in some periods. Maybe our friend George Hamstra will find that Netgain Motors has outsold all Russian EV makers for the last four years.
