I always enjoy getting mail from Chris Sharp and he recently provided some great information about how to get to and from the FVEAA meetings via the BNSF train and public transportation.

The Route 673 Pace Bus has a route on weekdays from the Route 59 train station to the Community Christian Church 1635 Emerson Lane in Naperville where we hold our meetings, and this could be quite convenient for folks downtown not wanting to drive.

FROM CHICAGO TO NAPERVILLE

BNSF train #1267 leaves Chicago Union Station at 5:22 p.m. arriving at Rt 59 at 6:03 p.m. (Note this train does not stop in Berwyn)

The Route #673 Park-n-Ride Bus then leaves the Rt 59 station 6:05 p.m. and arrives at CCC at 6:22 p.m. just before we start to open the doors for the meeting.

OR

BNSF train #1277 leaves Chicago Union Station at 5:45 p.m. arriving at Rt 59 at 6:25 p.m. Then the Park-n-Ride Route #673 bus leaves the Rt 59 station at 6:27p.m and arrives at CCC at 6:45 p.m.

Rich's Ramblings Rich Carroll

As most are aware, significant research in new battery chemistries is being done under George Crabtree's J-CESR group at Argonne. While I believe they are the most significant player in new developments, I do keep an ear open to other research. This comes from the University of Illinois, and is a sodium battery with the possibility of also aiding in water desalination. The research was recently published in the *Journal of The Electrochemical Society*.

Now there's a sound idea

Public (Federal) Law 111-373 (a.k.a. The Pedestrian Safety Act of 2010) provides for Electric Vehicles and Hybrids to make 'alert sounds' when they are operated below the speed where tire noise, wind and other factors create enough noise to warn pedestrians about the vehicle approaching. That 'alert sound' was not defined in the law, but it was left to the National Highway Transportation Agency to create regulations. The law specifically states that it applies to new electric or hybrid vehicles. NHTSA was supposed to have regulations published in 2015, but those rules have been delayed until at least March, 2016.

Be aware that there are no mandatory pitch, no length, no changes in pitch, no volume specified in the law, but these should be covered by the specific regulations. I look for this to be fodder for the late night talk show hosts in their comedy monologues. The sound for EV's at low speed has yet to be announced, but it will likely be an electronic tone based noise.

Be aware that the National Federation for the Blind has pushed hard for these regulations. Their concern is that visually handicapped pedestrians would not know that a car was approaching, and the pedestrian, lacking warning, might be harmed. Suffice it to say, the responsibility for avoiding a car-pedestrian accident rests with the car driver.

Curiously, there is no pending regulations for three wheel vehicles, or for two wheeled vehicles including bicycles. Many states have a requirement that bicycles have a warning system, a horn or a bell, but that law is not enforced. I could not find an Illinois law, but Secretary of State Jesse White has a pamphlet for bicyclists, called Bicycle Rules of the Road, which tells cyclists to make sure they have, among other requirements, a horn or bell that can be heard up to 100 feet.

(http://www.cyberdriveillinois.com/publications/pdf_publications/dsd_a143.pdf) So, with this soon to be introduced regulation for EV's, we will have cars honking horns, EV's making some (likely) tone, trucks with air horns, silent three wheelers, motorcycles with a buzzer or horn, and bicycles with bells or horns. Somehow this cacophony of sounds is supposed to be a warning to visually handicapped folks. Sounds like more noise pollution to me.

Most legislators will tell you that their primary function is to create reasonable laws. Unfortunately, I think, for many that their primary function is to get reelected, and to that end, look like they are creating reasonable laws.

Sec. 1-104.2. **Autocycle**. A 3-wheel motor vehicle that has a steering wheel and seating that does not require the operator to straddle or sit astride it.

(625 ILCS 5/1-147) (from Ch. 95 1/2, par. 1-147)

Sec. 1-147. Motorcycle. Every motor vehicle having a seat or saddle for the use of the rider and designed to travel on not more than 3 wheels in contact with the ground, but excluding an **autocycle** or tractor.
